Storage and Disposal:

STORAGE AND DISPOSAL:

Keep out of reach of children. Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight.

Bag packaging only

Single-rinse or shake remainder into application equipment. Do not dispose of undiluted chemicals on site. Puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

Plastic pail packaging only

Triple-rinse containers before disposal. Dispose of rinsate or any undiluted chemical according to state/territory legislative requirements. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

Will irritate the eyes and skin. Avoid contact with eyes and skin. When opening the container and using the product, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing), elbow-length PVC gloves, goggles and disposable dust mask.
